## New Year Will Bring New Rules for Disposing of Electronic Devices

New rules for disposing of electronic devices that took effect on **January 24, 2013**, will prohibit consumers from throwing away laptops, computers, monitors, televisions, and other such electronics with their trash. Under the state Covered Device Recycling Act of 2010, waste haulers will no longer be able to take these items unless the municipality has a curbside electronics collection program that ultimately sends the devices to an electronics recycler. “Proper recycling is important because there are millions and millions of devices, they have a limited useful life span, and they contain heavy metals, such as lead, cadmium, and mercury, as well as other materials that do not belong in the normal trash stream,” State Secretary of Environmental Protection Michael Krancer said in a news release. Many of these devices also contain valuable metals, such as gold, silver, and platinum, and base metals, such as copper, iron, and aluminum that can be separated and reused in new products.

The law also requires manufacturers of covered devices to provide for the collection, transportation, and recycling of these items through one-day events, permanent collection programs, or mail-back options. Some retailers also accept electronics for recycling either at no charge or in exchange for rebates or coupons.

**Oneida Township has scheduled Clean-Up days for:**

**APRIL 25 & 26, 2014**

**For residents of the township only.** Hours will be 8 am to 8 pm on Friday and 8 am to 5 pm on Saturday.

We will take tires, but there will be a disposal fee. Refrigerators and freezers must have doors removed.

We will NOT take: hazardous waste, liquid paints or solvents, gas or propane cylinders, lawn or yard waste, or household garbage.

No construction waste. There are no pick-ups, delivered waste only.

We will take electronic trash, but: **ELECTRONICS MUST BE SEPARATED FROM OTHER TRASH.** This includes desktop computers, laptops, monitors, peripherals such as: keyboard, mouse, printer, speakers and all TV's. Also e-readers that browse the internet.
