

Through an agreement with Park's Garbage Service, Inc. and the County Recycling Program. Oneida Township has been able to obtain a recycling bin, finally! At the June township meeting, Ms. Lou Ann Shontz told the Supervisors that the county would be willing to give the township a recycling bin, but would not pay the tipping fees, an arrangement that is in place for bins in other townships. Mr. Ralph Parks then said Park's Garbage would be willing to pay those tipping fees as long as Oneida Township was willing to police the area and make sure that it was properly maintained and not used for anything other than approved recycling material. The Supervisors quickly agreed. Now it is up to the residents to make sure that they use it only for those items listed on the sides of the bin. Items do not need to be separated. Those items include:

CARDBOARD: Cardboard boxes, pizza boxes, cereal and jello boxes, paper towel and toilet paper rolls, paperboard packaging (tissue and shoe boxes).

Prepare: Removing all packaging, Styrofoam, peanuts, bubble wrap, etc. and flatten all boxes.

Unacceptable: Plastic bags, food soiled cardboard, wax coated cardboard, like milk cartons.

Note: plastic bags may be recycled at your grocery store.

PAPER: Office paper, any color, shredded paper, single cut only-no cross cut, newspapers and inserts, magazines and catalogs, mail and envelopes, paper bags, phone books.

Prepare: Remove non paper objects from paper items.

ALUMINUM: Aluminum and steel food and beverage cans, aerosol cans, plastic bottles with necks smaller than their bases, clear, green and brown glass food containers.

Prepare: Remove all caps and lids and rinse thoroughly. You may leave on labels and neck rings.

Unacceptable: Aluminum other than food cans, scrap metal, plastic cups, tubs, cups, trays and bags. Deli/take out containers, broken glass, windows, mirrors, ceramics, light bulbs and drinking glasses.

Park's is unable to take electronic waste .
