## ONEIDA TOWNSHIP SUPERVISORS' MEETING JUNE 7, 2023 7:30 PM ONEIDA TOWNSHIP MUNICIPAL BUILDING

OPENING: Mr. Skipper opened the meeting with the "Pledge of Allegiance".

VISITORS' COMMENTS: None

MINUTES/FINANCIAL REPORTS: The CD with Community State Bank matured and was cashed out into The Huntingdon Savings Bank Savings account, to be transferred into a CD in the near future. Mr. Ferrenberg motioned to approve the minutes and financial reports from last month and it was seconded by Mr. Magill.

ROADMASTER'S REPORT: Leaf Blowing was done by Mr. Terry Hawn. Three sewer calls were made last month. There are 4 grinder pumps on hand, with another being rebuilt. If buying new pumps, the best price is usually for 6 at a time. Mr. Nick Newfield has started the advertising process necessary to pass the Solar Ordinance. Mr. Skipper motioned to approve the Solar Ordinance as completed by Mr. Newfield. It was seconded by Mr. Ferrenberg.

There were no bids on the seal coating advertised for the road project this year. Mr. Magill suggested that Hammaker East out of Fayetteville may do such work.

Mr. Skipper motioned to approve paying half for a new refrigerator, the cost to be shared with HRF&R. It was seconded by Mr. Ferrenberg.

It was seconded by Mr. Ferrenberg.
