## ONEIDA TOWNSHIP SUPERVISORS' MEETING DECEMBER 6, 2023 7:30 PM ONEIDA TOWNSHIP MUNICIPAL BUILDING

PRESENT: John Skipper, James Ferrenberg, Stephen Magill, Henry Strong, Chris Carper, Andrew Los, Kevin Fluke, Peggy Stullen, James Grissinger, Timothy Furlong, Sarah Hayden

OPENING: Mr. Skipper opened the meeting with the "Pledge of Allegiance".

VISITORS' COMMENTS: Mr. Fluke stated that he serves as a supervisor for Penn township and visits other township meetings to see how they do things.

MINUTES/FINANCIAL REPORTS: Mr. Strong reported that all the townships' fixed assets are at interest rates over 5%. He stated that there would be approximately \$32,000 in outflow during January and February. Mr. Strong mentioned that he would like to keep a close eye on the sewer account due to the increase in rate from Huntingdon Borough and the increase in price of grinder pumps. He also brought attention to fact that the amount owed on the PIB loan is down almost \$40,000 from last year. Mr. Skipper thanked Mr. Strong for his time and expertise overseeing the townships finances.

Mr. Ferrenberg motioned to approve the minutes and financial reports from last month and it was seconded by Mr. Magill.

ROADMASTER'S REPORT: Mr. Carper reported that most of the roadwork for the month consisted of leaf blowing and cleaning out culverts, there was one PA1 call, the gutters on the building were cleaned, and antiskid was put down due to icy conditions one day this past month. He also stated that he replaced a sign at the intersection of Deforrest Rd and Standing Stone Rd due to an accident and reported the damage to the state police.

OLD BUSINESS: No old business.

NEW BUSINESS: Mr. Grissinger introduced himself as District Fire Chief and Mr. Furlong as Chief of HRFR. He gave a summary of their November report which included 29 incidents handled, \$45,863.18 in expenses, and approximately \$2,000 made from a sandwich sale. HRFR also toured mutual benefit buildings and escorted Santa to the tree lighting in the month of November. Mr. Skipper thanked them both.

Mr. Skipper motioned to approve the Resolution of Respect for Chris Shook. It was seconded by Mr. Magill. It was signed and will be submitted to the Daily News and a copy given to her family.

Mrs. Hayden confirmed with the supervisors that the annual reorganization meeting will be held on Tuesday January 2, 2024 at 7 PM.

Mr. Skipper thanked Mr. Magill for everything he has done for the township as December will be his last month as supervisor.

Mr. Ferrenberg motioned to adjourn the meeting and it was seconded by Mr. Magill.
