## ONEIDA TOWNSHIP SUPERVISORS' MEETING FEBRUARY 7, 2023 7:30 PM ONEIDA TOWNSHIP MUNICIPAL BUILDING

OPENING: Mr. Ferrenberg opened the meeting with the "Pledge of Allegiance".

VISITORS' COMMENTS: Mrs. Anderson asked about the status of some of the properties sighted for violations of the Nuisance Ordinance. Mr. Ferrenberg stated that the township has taken all actions available but the parcel owners have not yet complied.

MINUTES/FINANCIAL REPORTS: Mr. Strong reported the townships finances are right on track for the beginning of the year. He stated that a lot of insurance payments went out in January and there will be a few more in February.

Mr. Skipper motioned to approve the minutes and financial reports from last month and it was seconded by Mr. Los.

ROADMASTER'S REPORT: Mr. Carper reported that there were multiple snow events in January along with some high winds causing downed trees/limbs and culverts to need cleaned out. Mr. Carper also reported that the pickup truck was serviced this month and 1 grinder pump was replaced. He stated that there is a sign missing from Deforrest Road and that he ordered a replacement which has not come in yet.

OLD BUSINESS: Mrs. Hayden reported that the Oneida Township website was updated to include information about HRFR, fire hall rental, and clean-up days for 2024.

NEW BUSINESS: Mr. Ferrenberg made a motion to approve paying \$116.60 for Oneida Township's portion of the RAK tax program for 2024. Mr. Los seconded the motion.

Mrs. Hayden reported that thank you notes had been received from the Huntingdon County Library and Humane Society for contributions made by the township.

Mrs. Anderson stated that she would like to find out how to get a hidden driveway sign placed on Standing Stone Road before Anderson Lane. Mr. Skipper stated that we would have to contact PennDOT.

Mr. Skipper stated that there is an opening on the Oneida Township Planning Commission and if anyone is interested, or knows someone who may be interested to please let the supervisors know.

HRFR reported 44 incidents handled and \$30,830.74 in expenses for December. They also reported having good turnouts for their Thursday night shotgun matches held at McConnellstown Fire Hall.

Mr. Los motioned to adjourn the meeting and it was seconded by Mr. Skipper.
